The objective of the Project is to enhance the professional and economic competences of Afghan refugees as well as their chances for a successful return and reintegration into Afghan society.

The Project provides vocational training, market-oriented advisory services as well as capacity building measures for participating Iranian organizations. sequa makes use of its network in Germany and will involve German chambers and business associations in order to provide solid technical VET expertise to the Project.

The main partner of the Project in Iran is the Bureau for Aliens and Foreign Immigrant Affairs (BAFIA).
