## **Service Package for Adolescent living with or affected by HIV**

### **BACKGROUND/PURPOSE OF ASSIGNMENT**

The HIV epidemic is a long-term challenge that requires a sustainable response to end the epidemic as a public health threat. The Islamic Republic of Iran has made tangible commitments to this effect, namely incorporating the 90-90-90 goals in the 4th National Strategic Plan, which was endorsed by the High Council for Health & Food Safety in March 2017, and a Treat-All policy during the same year. However, there remains a significant structural, behavioural, and technical issues that the National AIDS Control Programme plans to address to achieve the 90-90-90 goals.

Adolescence is a critical period of human development, with rapid and increasing physical, hormonal, neural, psychosocial, cognitive, emotional, reproductive development, and maturation. Service package for adolescents and how they are delivered represent a significant determinant of quality of life for adolescents specially for those living with or affected by HIV. Specific interventions and delivery platforms and approaches to adolescent populations have shown significant improvements in health. It is important that programme managers and service providers understand what is taking place during adolescence as it provides insights into how to approach services and programming for this age group particularly for those living with or affected by HIV. Access to treatment and care for adolescents living with or affected by HIV also remained inadequate. Following HIV testing and counselling, linkages, retention in care and ART coverage rates for adolescents are generally lower than for other age groups. There are many challenges in effective interventions to support a sustainable treatment adherence and retention in care among adolescents. Inability to address these issues can lead to treatment failure and HIV related morbidity and mortality. Addressing these challenges and adapting systems to provide good quality, effective health care and social support for adolescents are needed. It is essential to consider specific needs of adolescents. Addressing the distinct and diverse needs of adolescents living with or affected by HIV to improve their HIV-related outcomes requires a comprehensive and integrated approach.

To do so, UNAIDS is supporting to develop service package for adolescent living with or affected by HIV to meet their needs and access to services.

### **DURATION OF WORK**

The assignment will take place from **10 Feb 2021 – 10 June 2021**.

### **LOCATION**

The work to be conducted in Tehran.

### **MAIN OBJECTIVE**

The main objective of this assignment is to develop comprehensive service package for adolescent living with or affected by HIV.

### **KEY ROLES AND RESPONSIBILITIES**

The contractual partner will:

- Conduct literature review about services given to adolescent living with or affected by HIV.
- Conduct need assessment on the status of services for adolescent living with or affected by HIV.
- Develop comprehensive service package: interventions and services regarding HIV prevention, diagnosis, treatment, care, and support with emphasis on disclosure counselling, partner notification and adherence to treatment including:

#### **1- Prevention:**

- HIV testing and counselling.
- HIV prevention modality
- STI counselling and prevention including related vaccine.

- Harm reduction services
- PrEP and Post-exposure prophylaxis

## 2- Treatment:

- Adherence support
- ARV medication

## 3- Care and support

- An introduction to an enabling environment for target audience to the basic psychosocial services including life skills and peer support.
- Disclosure counselling, including post disclosure support.
- Proper communication of health care providers and adolescent living with or affected by HIV, promoting ongoing discussion between the adolescent and care givers in the home environment.
- Developing parents and caregivers peer support mechanisms
- Proper communication of parents and adolescent living with or affected by HIV.
- Nutritional support

## 4- Information

Full information and counselling should be provided on all these topics within the package as well as where to access and link to other services.

- Update UNAIDS regularly on the progress of the assignment. This includes reports of literature review and need assessment, development of service package for adolescent living with or affected by HIV and final report. Final report should be both in Farsi and English.
- Provide the final report as agreed on CD or DVD and by email in Word™, Excel™ and PowerPoint™ formats as well as hard copies of any published material, where applicable. All raw data will be handed over electronically, or if not available electronically, in hard copy.
- Undertake to keep all information regarding the report and the content thereof confidential.

**In line with UNAIDS policies and procedures on the COVID-19 pandemic, all meetings and workshops conducted within the framework of this assignment are required to be virtual.**

## **KEY OUTPUTS**

1. Report of literature review and need assessment.
2. Development of service package for adolescent living with or affected by HIV.
3. Final report including a detailed Gantt chart and outlining all pertinent operational and methodological aspects of the assignment.

- Principal Investigator (PI): Holds Ph.D degree in epidemiology, public health or health system
- Co- Investigators (Co-I): Hold speciality or sub- speciality in Medicine, M.D degree in infectious disease, paediatrics infectious disease or Ph.D degree in public health or health system

#### **b. Experience**

- Principal Investigator should have at least five years of experience on health or HIV programs; Has proven experience in guideline, protocol, and service package development in the fields of HIV, health, adolescent and prevention and treatment programmes.

- Has a functional financial system in place with a bank account under the name of the individual.

**c. Languages**

- Fluent in written Farsi and English
