Development of PrEP and condom programming road map for key populations

BACKGROUND/PURPOSE OF ASSIGNMENT

The HIV epidemic is a long-term challenge that requires a sustainable response to end the epidemic as a public health threat. The Islamic Republic of Iran has made tangible commitments to this effect, namely incorporating the 90-90-90 goals in the 4th National Strategic Plan, which was endorsed by the High Council for Health & Food Safety in March 2017, and a Treat-All policy during the same year. However, there remains a significant structural, behavioural, and technical issues that the National AIDS Control Programme plans to address to achieve the 90-90-90 goals.

The Prevention 2020 road map provides the basis for a country-led movement to scale up HIV prevention programmes as part of Fast-Tracking a comprehensive response to meet global and national targets and commitments to end AIDS as a public health threat by 2030.

The focus of the road map is on HIV primary prevention and the promotion and provision of effective tools to prevent HIV infections. It emphasizes on Pre- Exposure Prophylaxis (PrEP), condom programming focusing on key populations (KPs) at risk so that they can prevent infection. Primary prevention complements the preventive effects of treatment. Its programmes are often the first entry point for individuals to HIV testing and treatment. PrEP has shown considerable impact in reducing HIV infections when provided as an additional HIV prevention choice to Key population. it tackles the contextual factors that put people at risk of HIV infection and prevent them from accessing services. Condoms play a special role in combating the spread of HIV/AIDS because they are presently the only devices that protect against sexually transmitted HIV. However, high costs to users, limited availability and accessibility, and negative perceptions of condoms have created a gap between the number of condoms distributed and the amount needed for key populations to prevent HIV/STIs. Condom programming is a strategic approach to ensure that persons at risk of HIV/STIs are motivated to use condoms, have access to quality condoms, and can use them consistently and correctly. Improved condom programming can help close the gap in condom supply and use and reduce the spread of HIV. Moreover, experience has shown that actions to increase uptake and use of effective barrier methods are more successful and sustainable when they are part of a strategic comprehensive prevention programme.

To do so, UNAIDS is supporting to develop of PrEP and condom programming road map for key population in line with the National Strategic Plan.

DURATION OF WORK

The assignment will take place from 1 June 2021 - 30 Sep 2021.

LOCATION

The work to be conducted in Iran.

MAIN OBJECTIVE

The main objective of this assignment is to develop PrEP and condom programming road map in line with Iran's fifth National Strategic Plan (NSP).

KEY ROLES AND RESPONSIBILITIES

The contractual partner will:

- To conduct need assessment and situation analysis pertaining to HIV prevention programme in Iran to gain background information on the various components of PrEP and condom programme framework (leadership and coordination; demand, access, and utilization; supply and commodity security; and support).
- To develop a comprehensive and integrated plan for PrEP and condom programme.
- To develop a multi-year operational plan and budget for PrEP and condom programme.
- To identify available, committed, and potential resources at the local and national levels. Determining funding gaps in the operational plan.
- To recommend on ways of expanding access and use of PreP and condom for key populations including social marketing mechanism.
- To link the operational plan to the existing logistics system including systems for forecasting, procurement, distribution, and warehousing.
- To recommend on combining services with community empowerment activities among KPs in order to increase consistent use.
- To recommend on appropriate monitoring plan.
- Update UNAIDS regularly on the progress of the assignment. This includes a report of need assessment
 and situation analysis, interim report, final report on development of PrEP and condom programming
 road map for key populations both in Farsi and English and development of PrEP and condom
 programming roadmap for key populations.
- Provide the final report as agreed on CD or DVD and by email in Word™, Excel™ and PowerPoint™ formats as well as hard copies of any published material, where applicable. All raw data will be handed over electronically, or if not available electronically, in hard copy.
- Undertake to keep all information regarding the report and the content thereof confidential.
