ABOUT THE UN SYSTEM-WIDE COVID-19 VACCINATION PROGRAMME

The UN is committed to ensuring the protection of its personnel. Tasked by the Secretary-General, the Department of Operational Support (DOS) is leading a coordinated, UN-system-wide effort to ensure the availability of vaccine to UN personnel, their dependents and implementing partners. The roll-out of the UN System-wide COVID-19 Vaccination Programme (the "Programme") for UN personnel will provide a significant boost to the ability of personnel to stay and deliver on the Organization's mandates, to support beneficiaries in the communities they serve, and to contribute to our on-going work to recover better together from the pandemic. ABOUT THE VACCINATION CERTIFICATE

This document certifies the vaccination certificate issued for the individual and that the individual has administered the requisite 1st Dose COVID-19 vaccine, COVISHIELD[™] (ChAdOx1 nCoV- 19) - AstraZeneca/4121Z005 during May-June 2021 and 2nd Dose COVID-19 vaccine, COVISHIELD[™] (ChAdOx1 nCoV- 19) - AstraZeneca/4121Z026 during July-August 2021 by the Ministry of Health approved West Nikan Hospital medical staff under the supervision of the Ministry of Health and Medical Education and the World Health Organization in the Islamic Republic of Iran.

VACCINES DISTRIBUTED THROGH THE UN VACCINATION PROGRAMME

All vaccines administered through the Programme have been approved under emergency use listing procedures (EUL) by the World Health Organization, after a rigorous assessment of efficacyand safety.

In particular, the UN has acquired doses of:

- COVISHIELD, the version of AstraZeneca/Oxford COVID-19 vaccine manufactured by the Serum Institute of India, approved under emergency use listing procedures (EUL) by the WHO.

All vaccines administered through this programme were done so by authorized medical personnel under the supervision of a Senior medical personnel (Chief Medical Officer, head of nursing staff).
